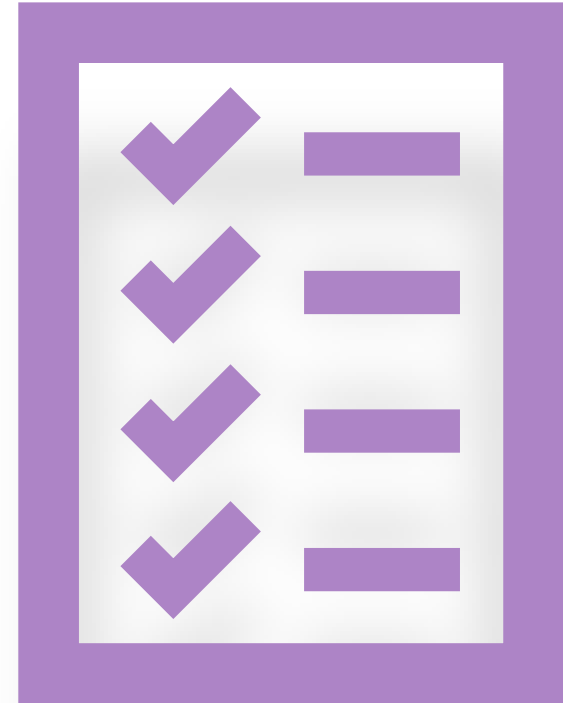

Eligibility



Minimum GPA of 2.5



2.5 GPA in the term immediately preceding the exchange



Full time classroom enrollment in the semester prior to and after the exchange



No incomplete grades from previous term



No outstanding financial obligations



No current or pending probationary status due to academic dishonesty



No current or pending probationary status or disciplinary action for violation of the student code of conduct

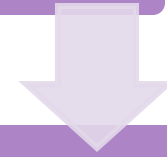


Must not be currently incarcerated, be on probation, parole or have any pending legal judgements
