### **Course Description**

SCI 102 is an inquiry-based science course for elementary education majors. The course is divided into three parts: Physics, Chemistry, and Biology. In the Physics part of the course, through a series of laboratory activities, students will learn both the charge model and the circuit model. In the Chemistry part of the course, again, through a series of laboratory activities, students will learn about chemical reactions involving electron transfer, which serve as the foundation for understanding batteries. In the Biology part of the course, students will apply their knowledge of physics and chemistry to the neuromuscular and the cardiovascular systems in human beings.

### **Course Goals**

SCI 102 is an approved General Education course in the Sciences. The activities in this course, which include laboratory experiments (based on guided inquiry and the predictive learning cycle) and writing assignments (recording observations in a journal and writing journal reports), are designed to help the student meet the following General Education goals at West Chester University: (goal #1) communicate effectively, (goal #2) employ quantitative concepts and mathematical methods and (goal #3) think critically and analytically. #### Assessment

Your final grade in this course will be based on your performance in each of the three parts of the course with equal weight (33%).

Each part of the course has its own set of assessments, which are described in separate syllabi, one for each part of the course. In general, though, three forms of assessment will appear in all three sections of the course: journal reports, quizzes, and exams. Journal reports consist of a series of free-response questions based on the laboratory activities that you perform in class and address the following Student Learning Objectives within the General Education goals met by this course.

Use relevant evidence gathered through accepted scholarly methods, and properly acknowledge sources of information, to support an idea.

Quizzes and exams contain a mix of free-response questions, short answer questions (often associated with diagrams of physical systems), and multiple-choice questions.
